(Notice under Section 28 of U.P. Awas Evam Vikas Parishad Adhiniyam-1965 (U.P. Act-(1) 1966)

The objections against the scheme shall be received at the office of Housing Commissioner (Land Acquisition Section), U.P. Awas Evam Vikas Parishad, 104 Mahatma Gandhi Marg, Lucknow or in the Office of the Executive Engineer, Construction Division Lucknow-09, U.P. Awas Evam Vikas Parishad, Office Complex, Sector-09, Vrindayan Yojna, Lucknow within 30 days from the first publication of this notice in Gazatte Uttar Pradesh. After the due date, no objection will be accepted. The objection so submitted should clearly mark out the correct Name of the Scheme and the Land/Building/Village Name/Khasra Number/Area of the land of the objector incorporated in the scheme and all other details.
